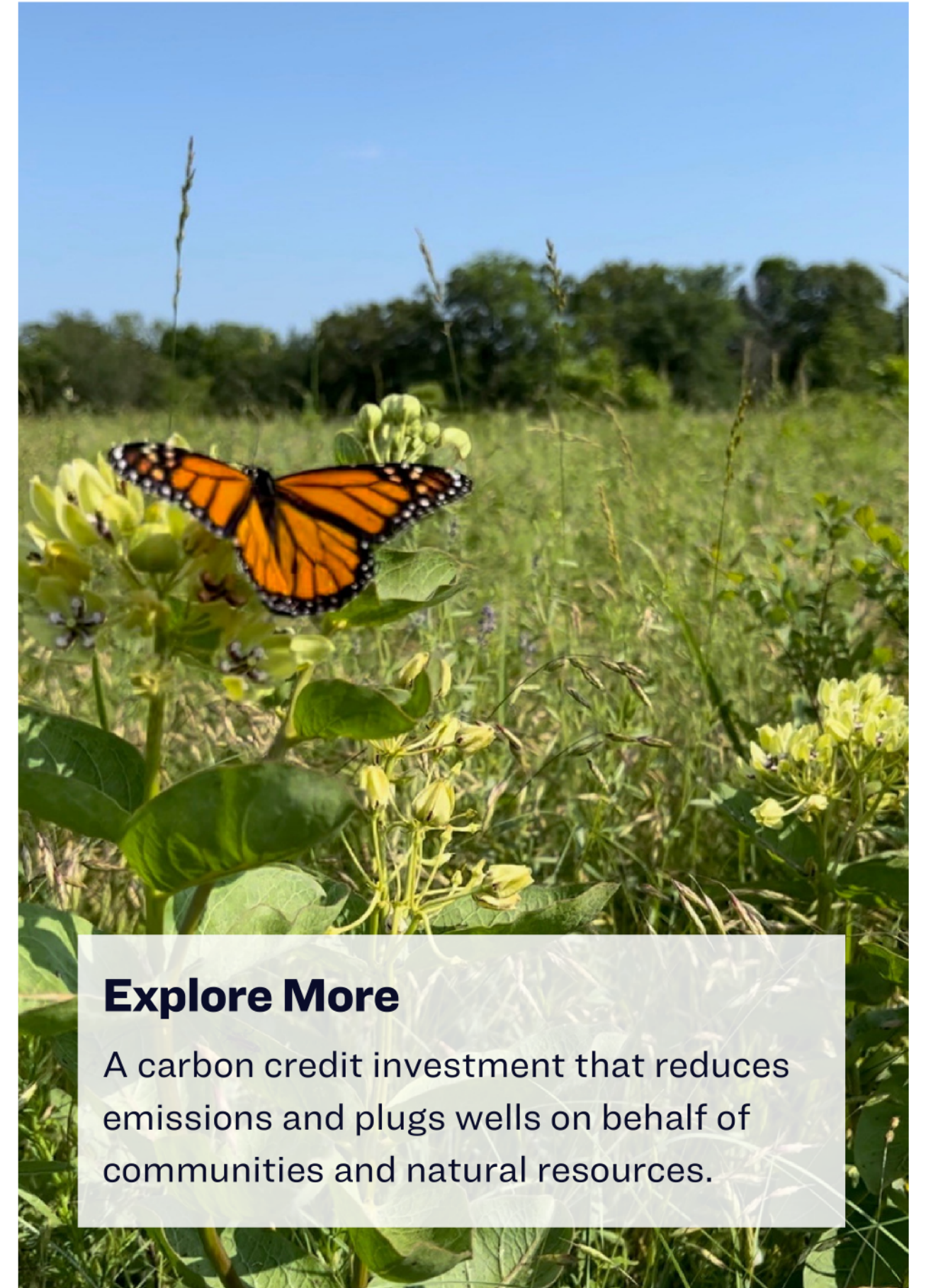

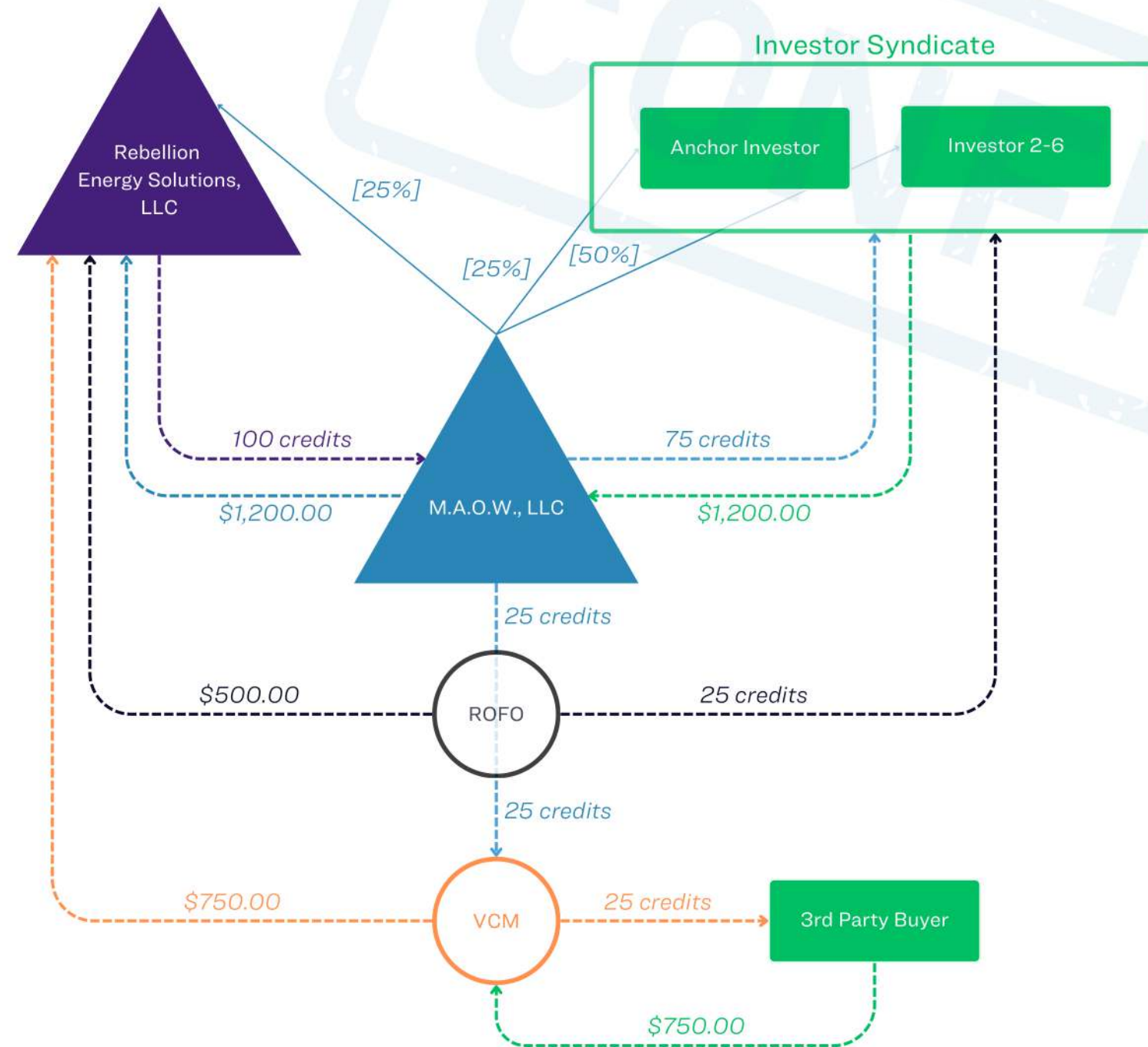

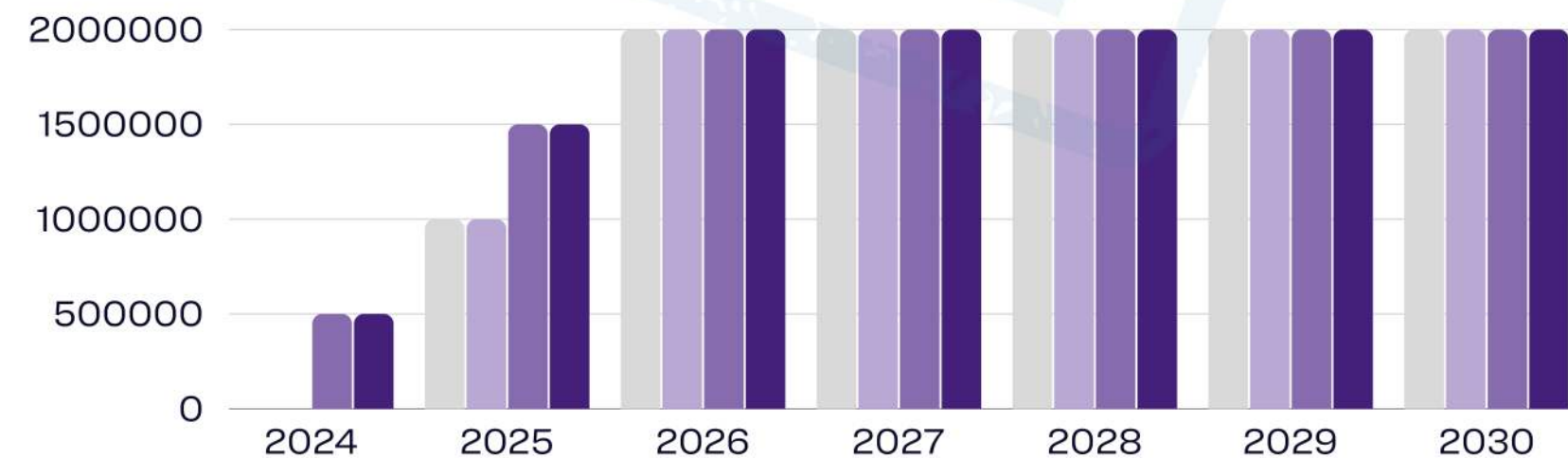


Investing in Methane Abatement from Orphan Wells (M.A.O.W.) means certainty of impact.

Methane Abatement from Orphan Wells



- Rebellion Energy Solutions will drop issued credits into Methane Abatement Partners, LLC following the below schedule.
- Those credits will then be transferred to investor syndicate ACR accounts proportionate to their equity interest.
- Members of the investor syndicate will have a right of first offer (ROFO) on excess credits that, if not exercised, will send them to the open market.
- Rebellion's proportionate share of credits (excess), once sold, will set the price for future issuances.
